Maturity of Franklin Templeton Opportunities Funds – Franklin Global Target Euro Income 2025 Fund (the "Fund")

Dear Shareholder,

We, the Board of Directors (the "**Board**") of Franklin Templeton Opportunities Funds are writing to let you know that the Fund, launched on 17 February 2020 for a period of five years, will reach its predetermined maturity date on 24 July 2025 (the "**Maturity Date**") which in accordance with the terms of the Prospectus will result in the Fund to be put into liquidation.

How we will operate the liquidation

Franklin Templeton International Services S.à r.l., as Management Company of the Fund, confirms it will proceed with the liquidation of the Fund and the final NAV of the Fund is consequently expected to be calculated on 29 July 2025 (the "**Final NAV**").

In respect to distribution share classes, please note that final dividends will be included in the calculation of the Final NAV.

The Board estimates that, under normal market conditions, the liquidation proceeds will be returned to you on or about 1st August 2025. However, if you deal through platforms, the transfer of the liquidation proceeds may be delayed.

What you need to know

Prior redemption or switch orders must be received within the Maturity Date but no later than 24 July 2025 at 18:00 CET (the "**Cut-off Time**"), subject to the terms and conditions as provided for in the Prospectus.

It is reminded that an exit charge of up to 1% may apply if a redemption request is made during the relevant Principal Investment Period as defined in the Prospectus, prior to the Maturity Date.

If no orders are received until the Cut-off Time, Shares will be automatically reimbursed, and proceeds will be returned to you as described in the section "How we will operate the liquidation".

There is no action required from you and we are handling the next steps on your behalf.
