

## **TERMS AND CONDITIONS FOR PARTICIPATING IN THE “REWARD SCHEME FOR NEW AEGEAN BONUS VISA CARDS”**

The bank under the name “**ALPHA BANK SOCIETE ANONYME**” [registered in Athens, Stadiou 41, P.C. 105 64., under company number 159029160000, Tel: 210 326 0000] (hereinafter referred to as “**Bank**”), as a member of the Visa Europe Services Inc. (hereinafter referred to as “**Visa**”), in the context of its partnership with the company under the name “**AEGEAN AIRLINES SOCIETE ANONYME**” trading as “**AEGEAN AIRLINES S.A.**” (hereinafter referred to as “**Company**”), is offering a reward scheme (hereinafter referred to as “**Reward Scheme**”), for the newly issued by the Bank, Aegean Bonus Visa cards, and more specifically for Aegean Bonus Visa Debit, Aegean Bonus Visa Credit Classic and Aegean Bonus Visa Credit Premium cards, following an application submitted during the period from 01/12/2025 to 31/12/2025 (hereinafter referred to as “**Card(s)**”) in order to enhance the issuance and use of the aforementioned cards, under the following terms and conditions for participating in the Reward Scheme.

### **1. Scope - Reward Period**

1.1. Main Cardholders who meet the conditions set out in terms 2.1. to 2.3. below, are rewarded with double Miles+Bonus award miles, in addition to the welcome Miles+Bonus miles offered, in accordance with the terms and conditions of use of their Card, and the detailed provisions of term 3 hereof.

1.2. The Reward Scheme commences on Monday, 01/12/2025, at 00:00 a.m. and ends on Wednesday 31/12/2025, at 11:59 p.m. (hereinafter referred to as “**Reward Period**”).

### **2. Reward conditions**

2.1. Main Cardholders who have acquired one (1) new main Card, issued by the Bank, following an application to the Bank within the Reward Period, using any of the means provided by the Bank, are automatically entitled to participate in the Reward Scheme. An additional necessary condition, for receiving the reward, is that the physical Card must be activated until 16/02/2026 (hereinafter referred to as “**Main Cardholders**”).

2.2. Additional necessary conditions for participating in the Reward Scheme are the following:

a) The Miles+Bonus Account Number of the main Cardholder (FFN) must be correctly stated on the Card application form. The main Cardholder is responsible for declaring the correct FFN number when applying for the Card.

b) The absence of any overdue debts to the Bank on any grounds by the date of activation of the Card.

c) All participants must be aged eighteen or over(18).

2.3. Cards that have been issued following a replacement or cancellation of any Aegean Bonus Visa card, which took place during the Reward Period or within twelve (12) months before the commencement of the Reward Scheme, are excluded from the present Reward Scheme.

2.4. Main Cardholders who meet the reward conditions (paragraphs 2.1., 2.2., 2.3), may call at 210 3260000, if they do not wish to be rewarded for any reason.

### **3. Reward**

3.1. Any main Cardholder who meets the conditions for participating in the Reward Scheme is rewarded with additional (to those mentioned in par. 3.2.) Miles+Bonus award miles. More specifically, Aegean Bonus Visa Debit card is awarded with additional 3.000 Miles+Bonus award miles, Aegean Bonus Visa Classic card is awarded with additional 5.000 Miles+Bonus award miles and Aegean Bonus Visa Premium card is awarded with additional 8.000 Miles+Bonus award miles. Provided that the main Cardholder activates his Card until 16/02/2026, the Miles+Bonus award miles are credited to his Miles+Bonus account by the Company.

3.2. The additional reward, according to par. 3.1., does not deprive the main Cardholders of the provision of tier and award miles, according to the terms and conditions of use of their new Card.

3.3. The reward provided for herein cannot be exchanged for cash or other prizes, is predetermined and binding for the main Cardholders, and therefore cannot be modified or changed at the choice of the latter.

3.4. For any further clarification in relation to the conditions and use of the reward by the main Cardholders, the latter should contact the Company via its service channels.

### **4. Personal Data**

In the context of processing personal data and provided that a new Card issuance application is submitted, the provisions set out in Alpha Bank's "Notification on the Processing of Personal Data" shall apply. The Notification describes in detail how the Bank processes personal data in its capacity as controller, and is continuously posted on Alpha Bank's website (<https://apps.alpha.gr/GDPR/files/GDPR.pdf>).

### **5. Other terms and conditions**

5.1. Participation in this Reward Scheme implies unconditional acceptance of all these terms and conditions. The Bank reserves the right to consider participation invalid if it considers that it conflicts with these terms and conditions for participating.

5.2. The Bank reserves the right to unilaterally amend the terms and conditions of participation in this Reward Scheme and/or the manner in which it is conducted, including the Reward Period, if deemed necessary and does not assume any liability in relation to any such amendment. Where any such amendment is made in accordance with the aforementioned, it shall be effective from the date on which the amended terms and conditions of participation are posted on the Bank's website ([www.alpha.gr/cards](http://www.alpha.gr/cards)).

5.3. Any dispute which may arise regarding the interpretation and/or implementation of the terms and conditions for participating in this Reward Scheme, shall be governed by Greek Law and shall be resolved exclusively by the competent Courts of Athens.

5.4. The present terms and conditions of participation in the Reward Scheme will be posted and always updated during the Reward Period, on the Bank's special website on the Alpha Bank card portal [www.alpha.gr/cards](http://www.alpha.gr/cards).
