- With regard to the Alpha Dimiourgo Plan and the Regular Investments that will be made in Alpha Asset Management MFMC Mutual Funds based on the Regular Investment Assignment Applications put into effect as of 01.02.2023, these will be charged with a UCITS Entry Fee, in line with the above table of commissions. An Entry Fee up to 0.25% on Alpha Asset Management MFMC Money Market Funds is applied to the Regular Investments in the Alpha Dimiourgo Plan carried out based on the Regular Investment Assignment Applications put into effect as of 01.03.2023. The redemption of UCITS shares acquired through the Alpha Dimiourgo Plan are not charged with a Redemption Fee. However, if the relevant securities / UCITS shares are unified or transferred from one Investment Account into another, normal Entry and Redemption Fees shall apply.
- Transfer Fee (redemption and new entry): When units are transferred to a different Mutual Fund, normal entry fees apply. In case of redemption of units for transfer to a different Mutual Fund, a 50% discount is applied to the commission rate referenced in the table above. If the redemption involves transfer to a mutual fund with equal or higher management fees, the redemption commission is zero.

- Alpha Bank receives the full Entry Fees paid by the Customer, as stated in the table above. In any case, the special pricing policy as determined by the foreign management company shall apply, in the sense that the entry fees received by the Bank may never exceed the corresponding fees described in the relevant prospectuses of the Mutual Funds and SICAV managed by the foreign asset management companies. However, if the entry fee described in the Mutual Funds and SICAV prospectuses is higher than the fee referenced in the above Entry Fee table, the Bank may not receive more than the fee referenced in the above table.

In relation to the UCITS Price List (Mutual Funds (MF) and SICAV) the following should be noted:

The pricing policy for Fees and Expenses as described in the relevant prospectuses shall otherwise apply.

The Bank receives a commission (Inducement) as a percentage of the UCITS management fees for providing investment services related to the reception and transmission of orders, and for providing non-independent investment advice. This commission (Inducement) relates to, on the part of the Bank, serving the shareholders in relation to the investment in UCITS, as well as potentially being the one keeping the relevant shareholders registers instead of the corresponding UCITS management company. This commission is mainly calculated as a percentage of the management fee, as follows: Commission (Inducement) for UCITS = Agreed rate of commission (Inducement) % x UCITS management fee

The individual commission rates (Inducement) vary depending on the UCITS, the share class and, occasionally, the investment category where each UCITS belongs or depending on the total service funds, and range between 0% to 65% of the annual management fees.

Investment Accounting Maintenance Fee – Alpha Finance Custodian Fee

The investment account maintenance fee per organised market is calculated as follows:

- Athens Exchange Group: as a percentage, standing at 0.0030% of the share price on an annual basis and at 0.0015% of the value of other securities (Bonds, Options, ETFs and other Securities) on an annual basis, which are registered under your brokerage account. The fee does not apply to portfolios with a value less than €15,000.
- In addition to the above, an annual fee of €3 also applies to each investment account with an average daily value over €15,000.
- Cyprus Stock Exchange: as a percentage standing at 0.0030% on the average daily share price registered under your brokerage account.
- International Markets: as a percentage, standing at 0.10% on the average daily price of the foreign shares registered under your brokerage account.

The annual Omnibus account maintenance and management fee is €500 plus VAT.

The minimum investment account maintenance fee stands at **€7** per quarter, whereas the relevant fee for Clients receiving online statement is **€3.5**.

The same fee applies to investment accounts that include dematerialised securities of companies that are not listed for trading in ATHEX or other foreign Regulated Markets.

The custodian fee for i) securities of companies that are listed and ii) dematerialised securities of companies that are not listed in Regulated Markets in Greece or abroad stands at **€2.5** per quarter, whereas the relevant fee for clients receiving updates online is **€1.25** (VAT included).

Commissions and Transaction Fees under Service Agreements for Alpha Bank Gold Personal Banking Services: The minimum investment account maintenance fee stands at €3.5 per quarter and the custodian fee stands at €1.25 per quarter (VAT included).

Holding a portfolio at Alpha Finance offers a number of services, including securities safekeeping, participation in corporate actions, payment of dividends; acquisition of shares, pledging of shares for participation in general meetings, sending of statements and Order Execution Confirmations, in the manner selected by customer (by post, fax or email).

Both fees (maintenance and custodian fee) are charged at the end of each calendar quarter.

In all other cases, the Alpha Finance Investment Services Single Member SA current List of Commissions and Fees shall apply.
