Re: PIMCO Funds: Global Investors Series plc (the “Company”)

Dear Shareholder,

We are writing to inform you of a change to the investment policies of the Funds.

The investment policy shall be amended in order to disclose the manner in which the Funds promote environmental characteristics in a way that meets the specific criteria contained in Article 8 of the Sustainable Finance Disclosure Regulation (EU) 2019 / 2088 (“**SFDR**”).

As you are aware, the Funds are currently classified as Article 9 funds under SFDR. Since March 2021, further information has been published regarding the specific requirements for Article 9 funds in particular a Q&A on the SFDR from the European Commission. The Manager now considers that the Funds’ approach to sustainable investment is through the promotion of environmental characteristics and Shareholders are advised that the Manager considers it appropriate to reclassify the Funds as Article 8 funds under the SFDR.

The Manager and Investment Advisor are of the view that there shall be no material alteration to the way in which the Funds are managed.

The costs and/or expenses that will be incurred in connection with the implementation of the change will be borne by the Manager, PIMCO Global Advisors (Ireland) Limited.

The updated Fund Supplements reflecting the changes are expected to be noted by the Central Bank of Ireland on/around **13 June 2022** and will be available on PIMCO’s website: **www.pimco.com** in due course.
